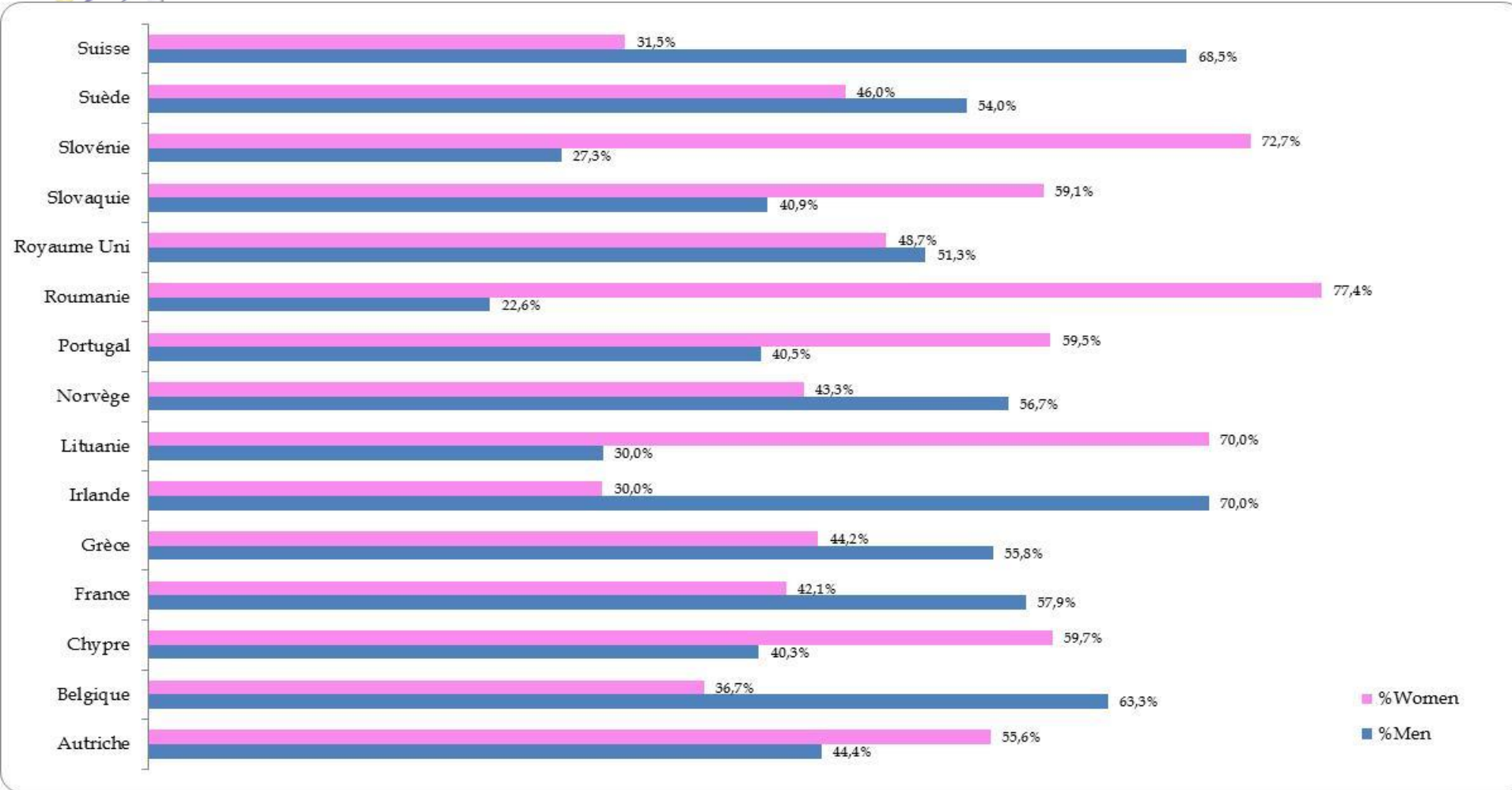

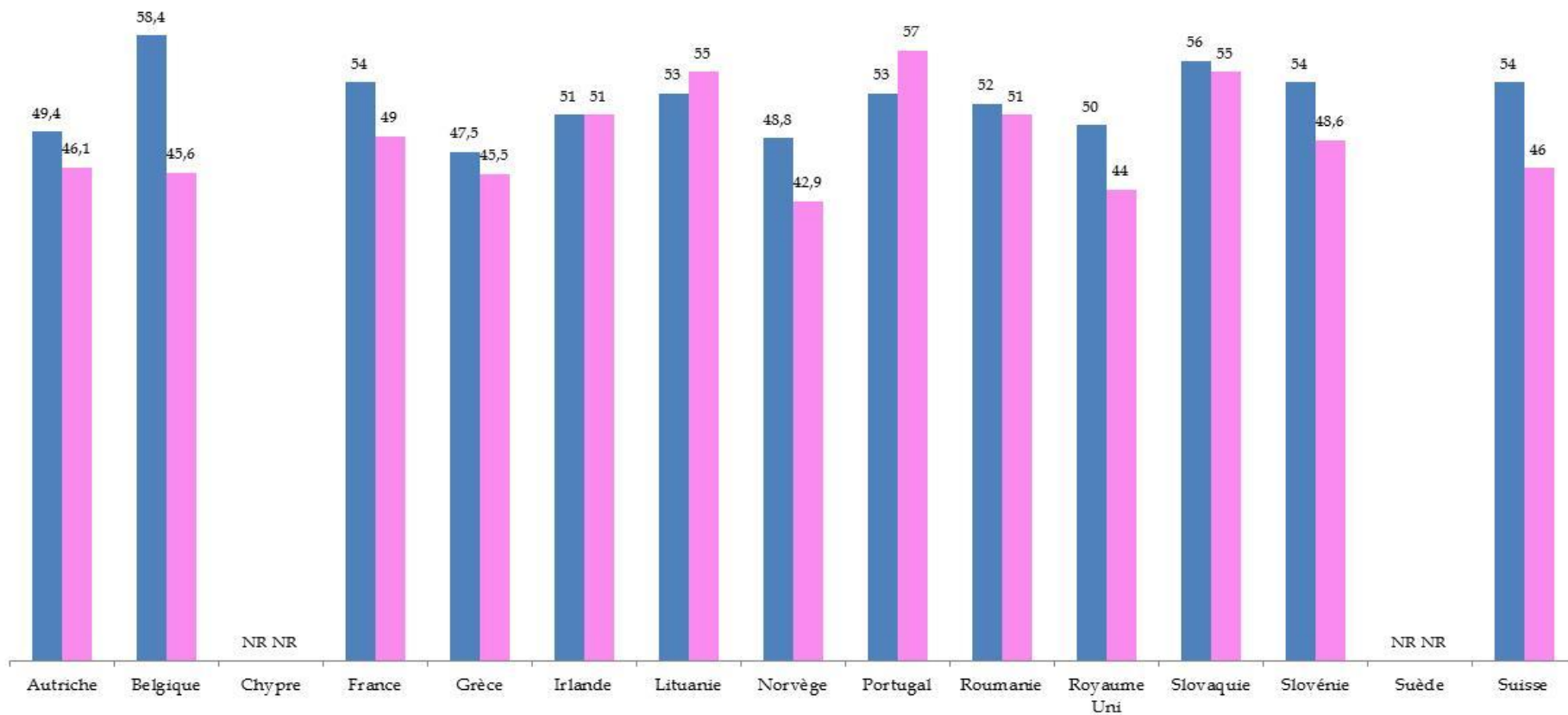

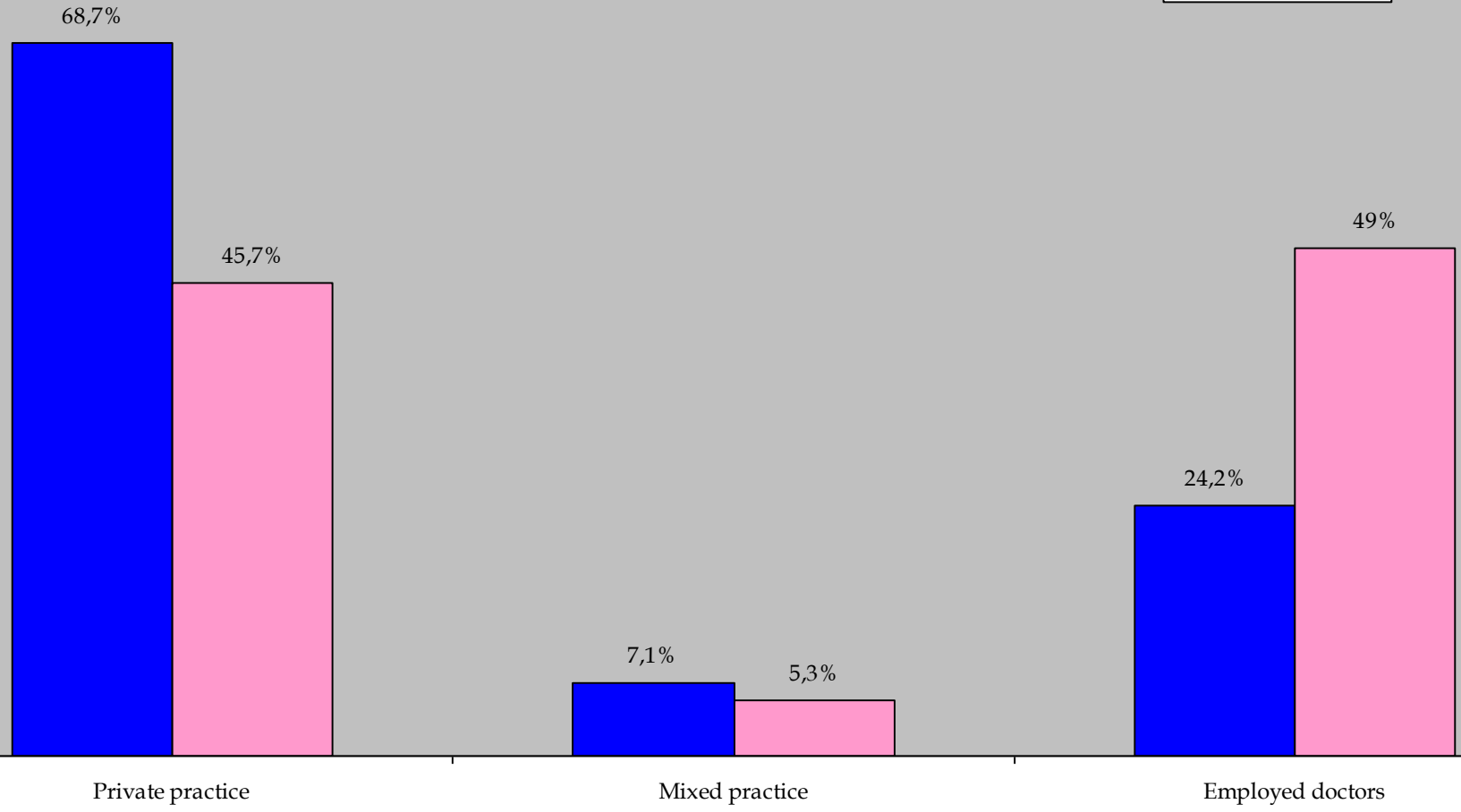


Type of practice of active general practitioners :

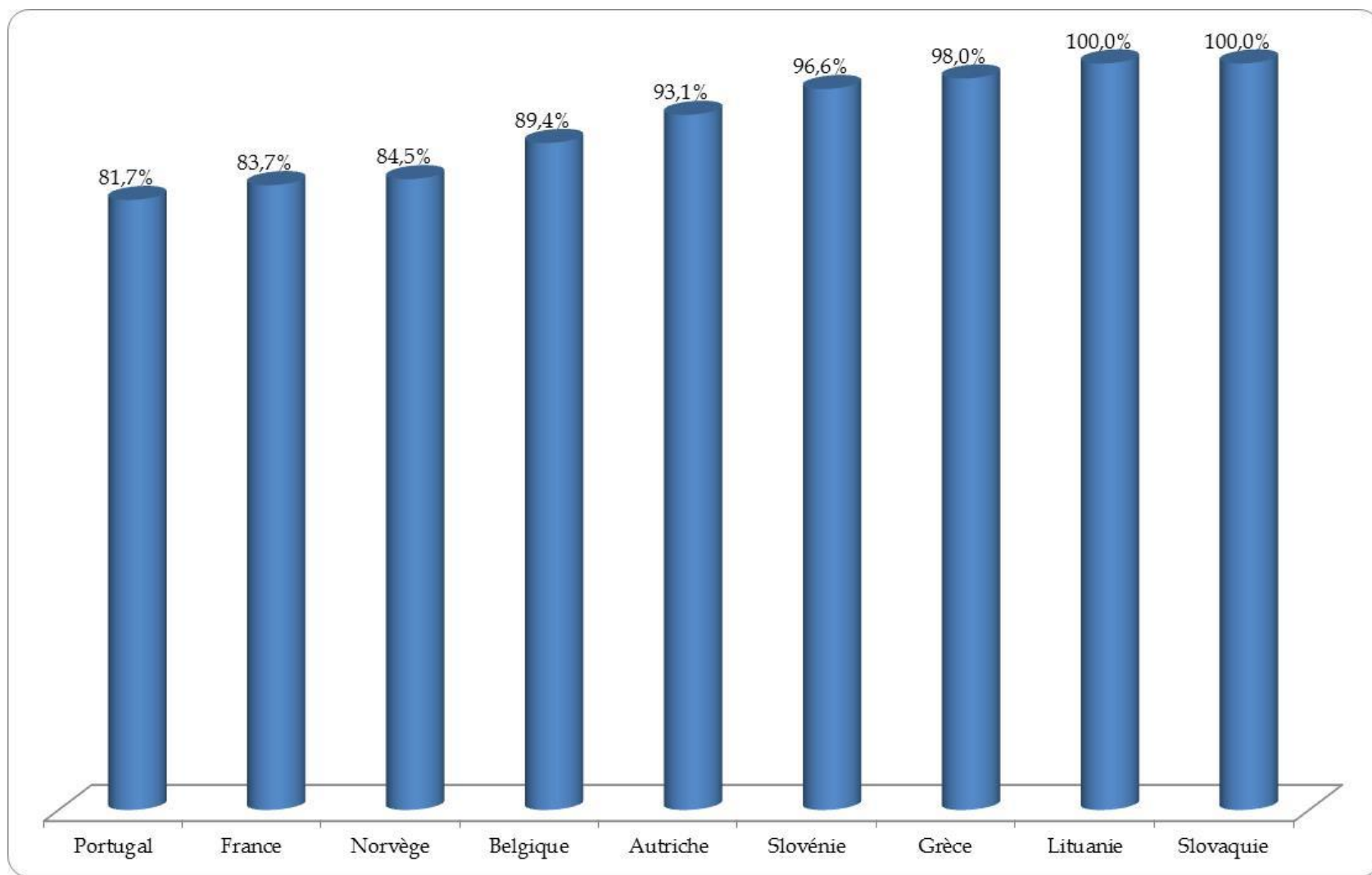

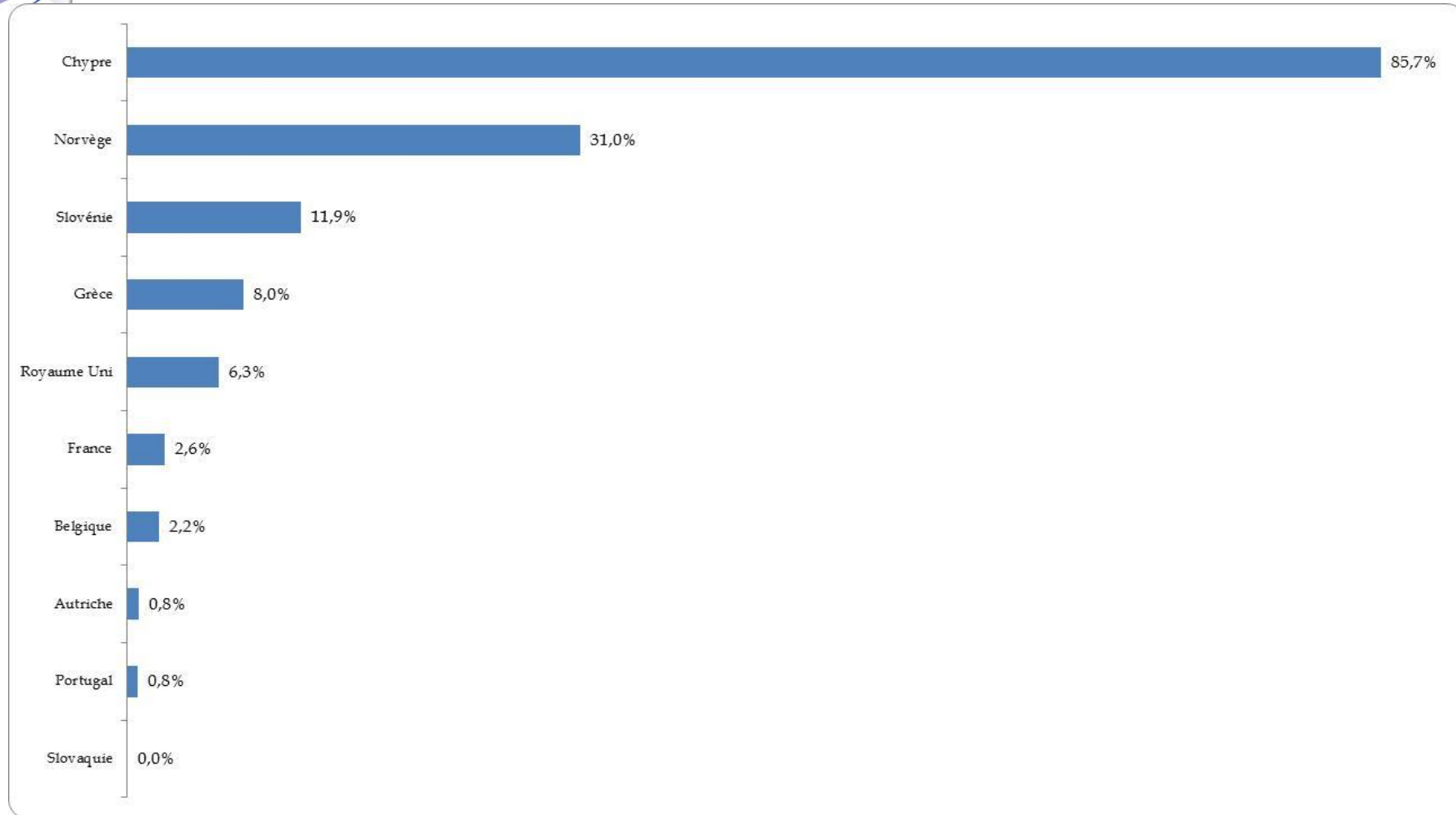

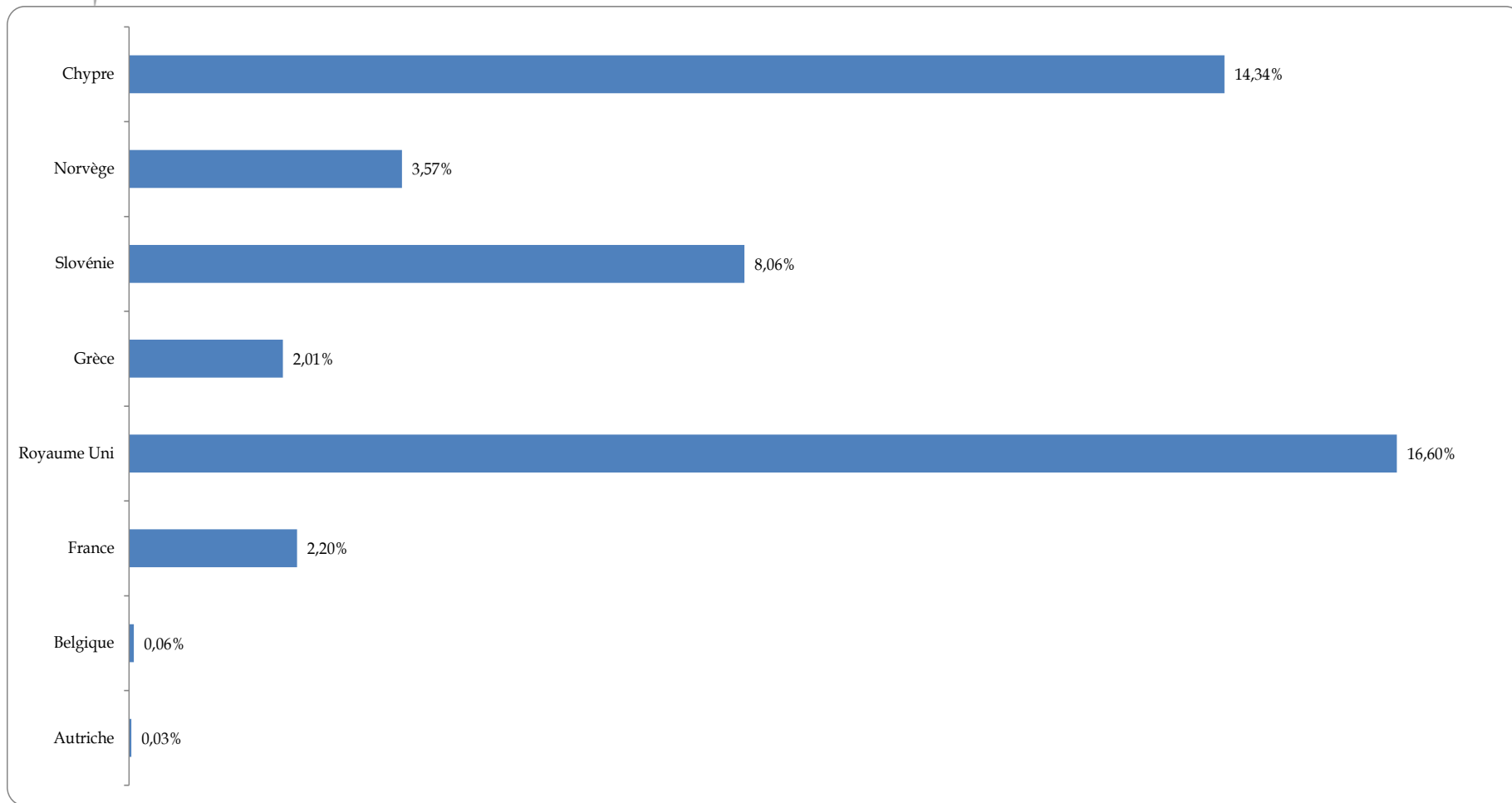

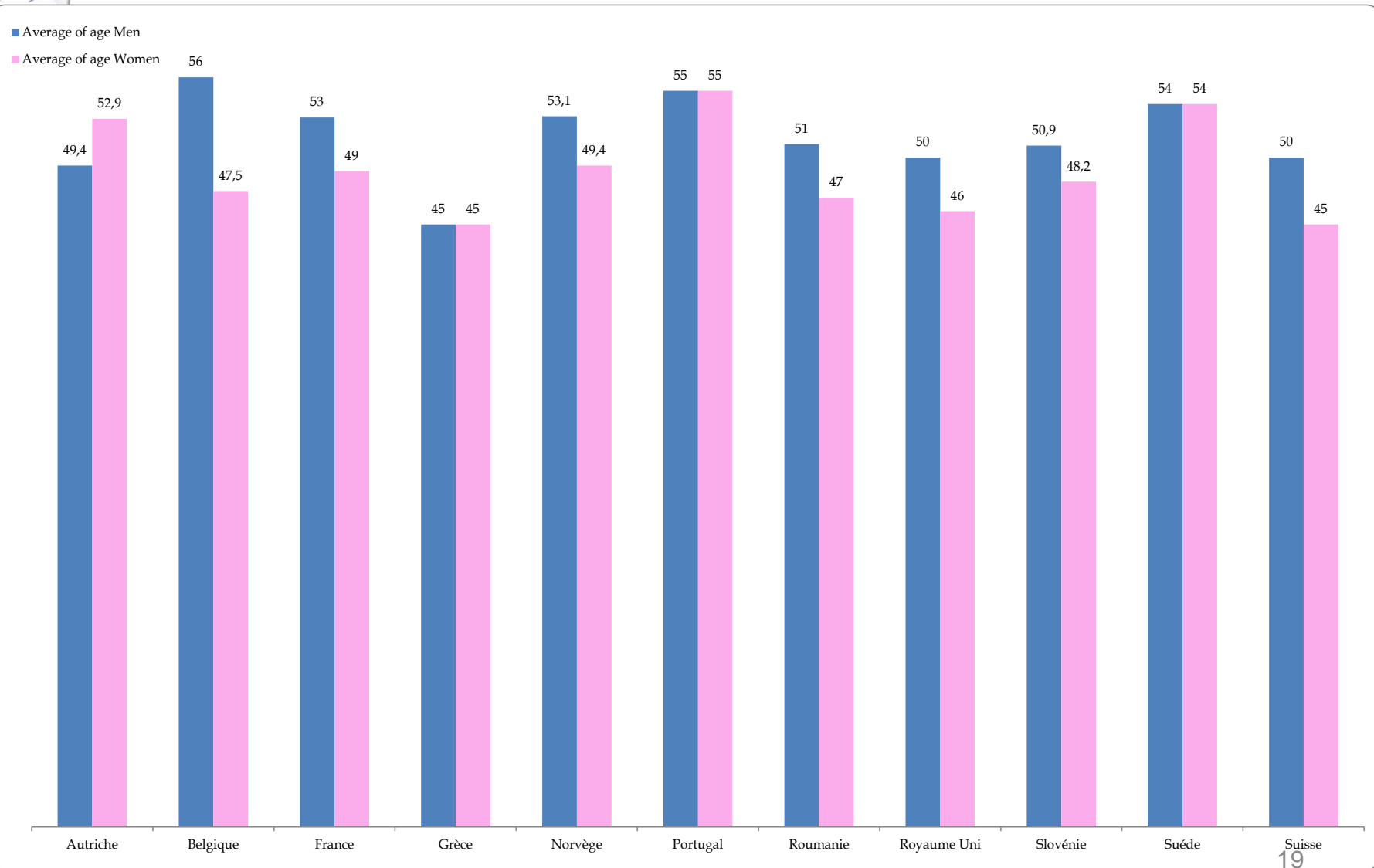

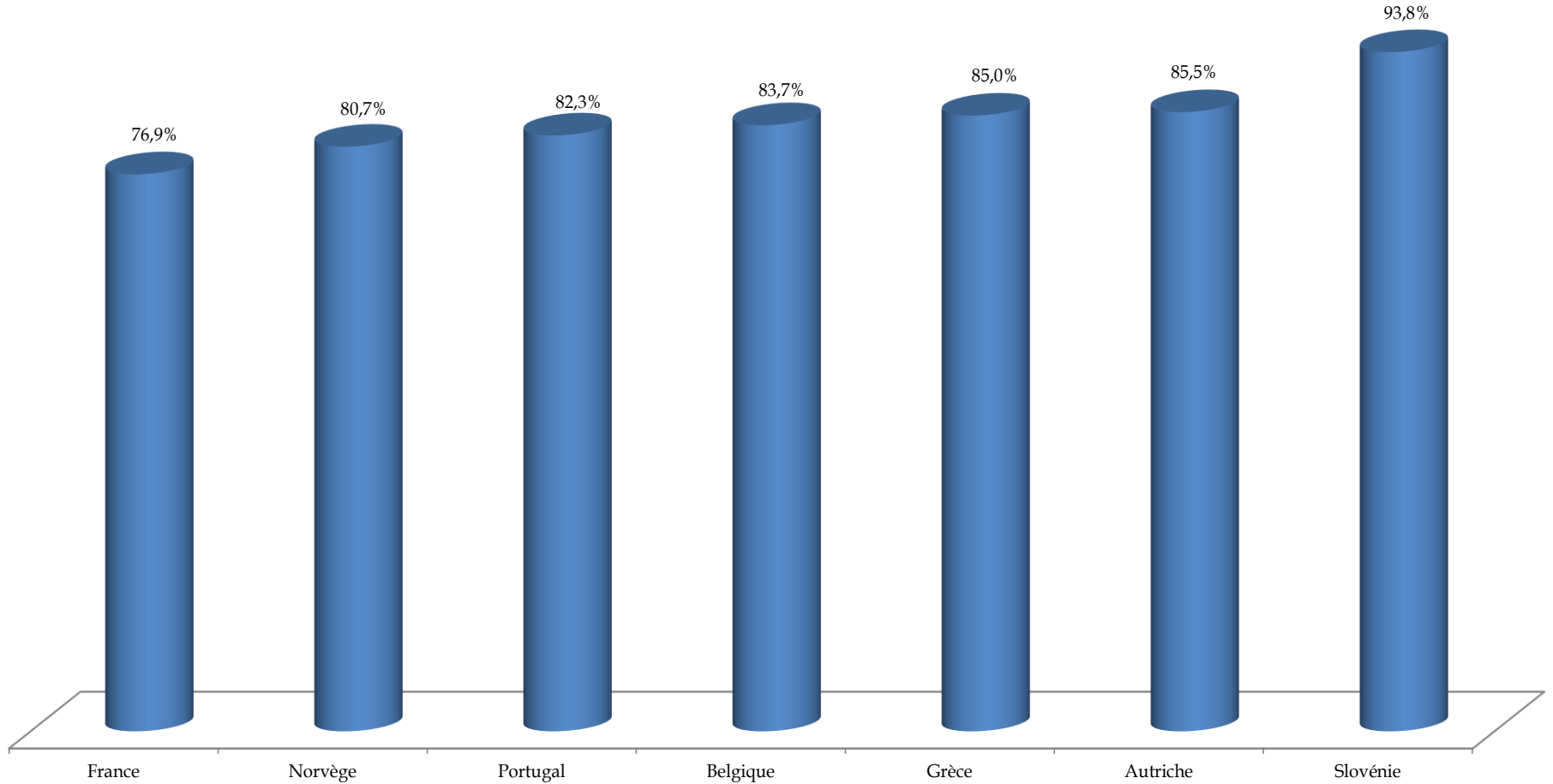


Type of practice of active general practitioners :

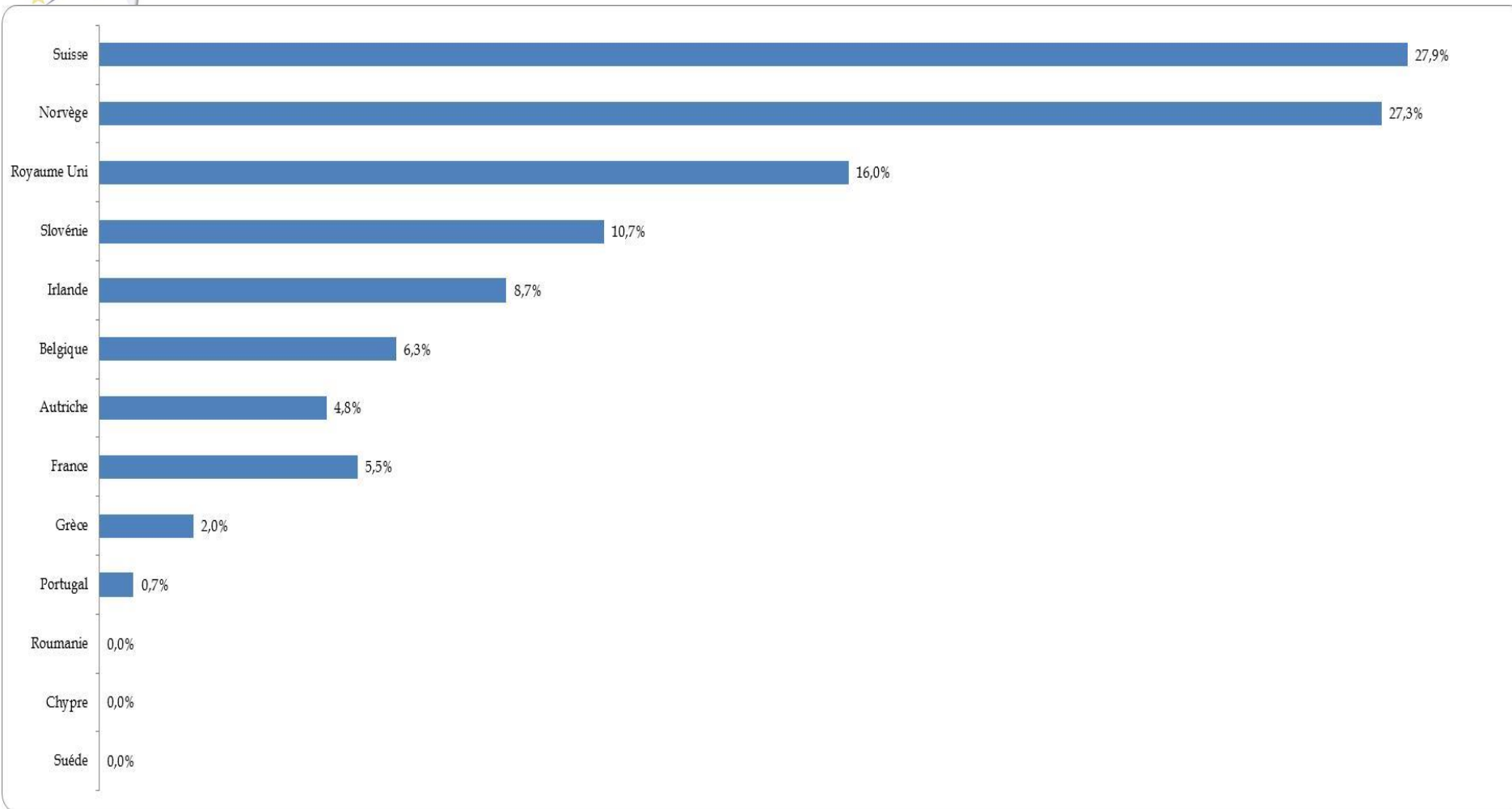

Country of graduation of medical specialists : EU

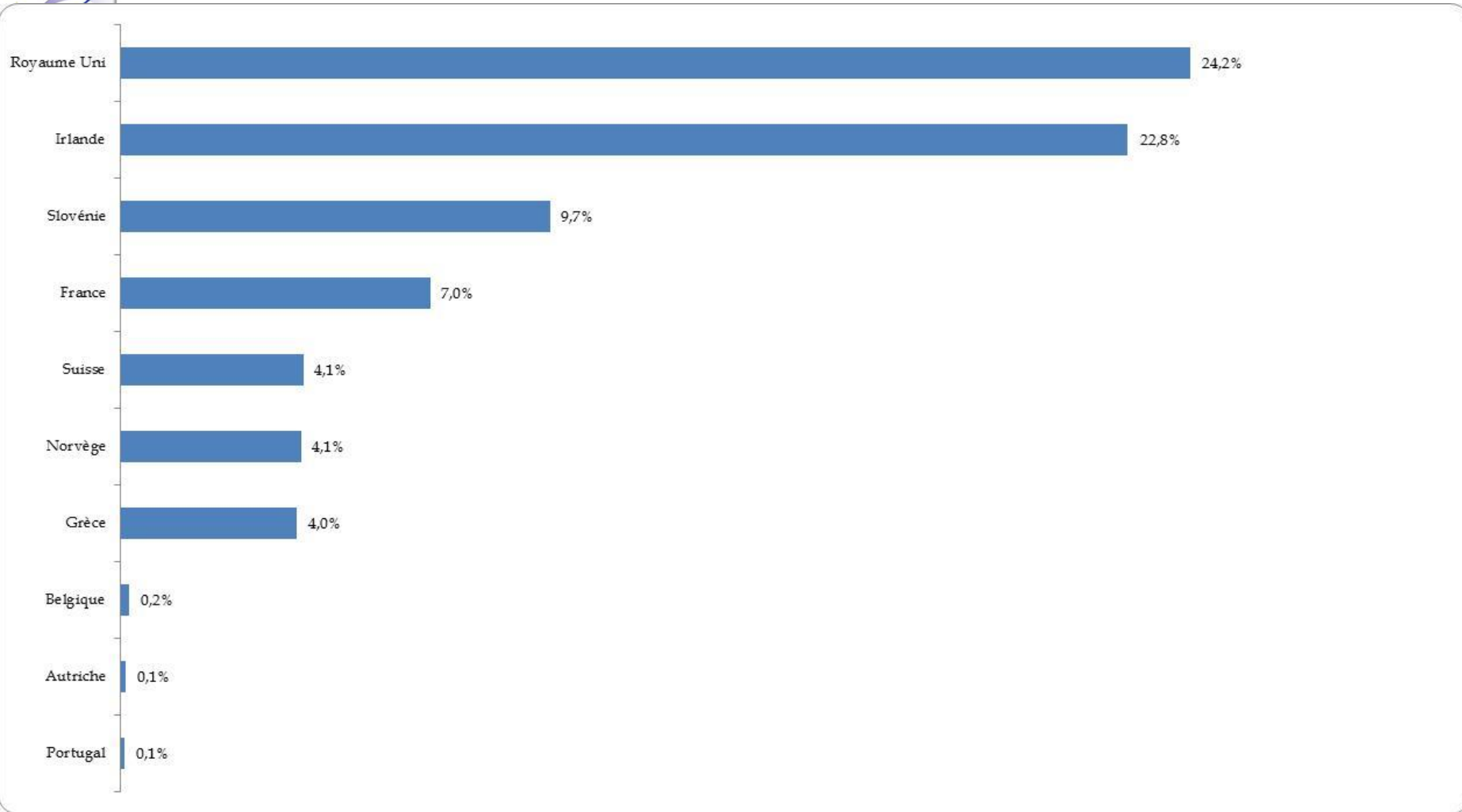

III – Terminology





Austria

Professionally active doctors can engage in a wide field of activities. They can practice as doctors in training or as licensed doctors, specialists or GPs in employed or self-employed capacity. A part from clinical activity, they have the possibility to practice e.g as specialists in occupational medicine, public health officers, military or police surgeons, or engage in scientific research in various medical fields at university departments.

Cyprus

A professionally active doctor should practice his or her trade in accordance with the Doctors Ethics Code and in order to secure the best interest on the patient. Moreover the physician has to seek ways to enhance his knowledge through academic research and participating in educational seminars.





Greece

1/ To practice medicine according to Medicine Ethics and Medical Science 2/ To provide healthcare services in the context of his/her specialty, with priority to patient safety and optimal quality of healthcare for all 3/ To provide healthcare services without discrimination on nationality-race-sex-religion, etc 4/ To be professionally updated on medical developments and evolutions

Ireland

The Irish Medical Council publishes a Guide to Professional Conduct and Ethics for Registered Medical Practitioners. The guide provides guidance to doctors on matters related to professional conduct and ethics, including professional conduct, responsibilities to patients, medical records and confidentiality, consent to medical and professional practice.





Lithuania

Treat and care for patient's health, continuous improvement.

Norway

According to the public authorities (SAK) : "A doctor's principal area of work is the diagnosis and treatment of patients. Doctors must possess a good knowledge of medicine and have good interpersonal skills. As a doctor, you will be responsible for ensuring that the treatment you give treats your patient's complaints and provides relief".

Portugal

To comply with the deontological standards that rule the practice of medical profession and with the rules of good medical practice.

Romania

Ensuring people's health by preventing disease, promoting, maintaining and recovering individual and community health (Law 95/2006)





Slovenia	Practicing doctors are employed, self employed, public or private. The work as public health specialist and supervising doctors in insurance companies or some other institutions
